2025/115 Welcome and introduction from the Chairman of the Parish Council Councillor Moore welcomed everyone to the meeting.

Councillor Banister had circulated a copy of the proposals. It was agreed that the Parish Council will express an interest in all three paths with a view to reconsidering the costs, if the tenders are higher than the quoted £41,000.

There was no update.

2025/124 To receive an update from the working party reviewing the Parish Council grant application process

Councillor Steele circulated a draft application form and draft set of rules. It was agreed that the Parish Councillors would forward any comments to Councillor Steele.

2025/125 To consider asking the Shipley Neighbourhood Policing Team to carry out a series of Speedwatch exercises in Menston together with a Speed Indicator Device

Councillor Steele advised the meeting that some Speedwatch exercises will take place when the highway improvements are complete.

It was agreed to add the purchase of a speed indicator device to the agenda for the next Parish Council meeting.

2025/126 Remembrance Services

The Clerk advised the meeting that rooms have been booked for both services on 9th and 11th November and representatives from the Lord Lieutenant's Office will attend both services. Councillor Moore agreed to contact both the Revd Jo Glenwright about conducting the services and Heather Norreys to find out what help she needs on the day. It was agreed to ask Councillor Greer if she would be able to contact the local schools and invite them to attend

It was agreed to add this item to the agenda for the September Parish Council meeting.

2025/127 To receive updates about any recent meetings of the following groups:

- Kirklands Menston Trust Councillor White advised the meeting that the refurbishment
 costs for the Wharfedale Room, toilet and kitchen are likely to exceed the estimates and
 she will be submitting an application to the next Parish Council meeting for some
 additional funds.
- Climate Action Menston The next meeting will take place in September.
- Wharfedale Greenway A meeting attended by a lot of stakeholders took place recently and discussed funding and routes.
- **LS29 Meeting** The minutes from the last meeting on 17th July have been circulated to the Parish Council. Two items were raised at the meeting: healthcare provision and secondary school provision. It was agreed that the Clerk will write to Menston Surgery expressing the Parish Council's concerns about the current provision of services in view of the increasing population. The next meeting will take place on 14th October.
- **Menston in Bloom** have arranged a Christmas tree chipping in the Kirklands car park on Saturday 3rd January.

2025/128 to receive any updates:

- Honk! Baybeat Band will be playing at Kirklands on 27th September as part of Honk!
 Bradford. It was agreed to set up a meeting to discuss how to run this event and to
 promote it in the Menston news.
- The Peter Finlay memorial bench –John Flinn is currently producing a design and this will be discussed at the next meeting of the Parks Group
- Travellers access fence no update.
- Barn Close no update.
- **Traffic proposals** Councillor Banister offered to talk to Bradford Council Highways about possible measures to make Four Lane Ends more pedestrian friendly.
- **Defibrillators** –Councillor Moore agreed to talk to Brian Firth about the installation of a defibrillator at the Fairfax Club and whether a possible defibrillator on The Homestead could be installed on a lamp post.
- Moving to gov.uk website and email addresses Councillor Houlihan has agreed to update the URL for the Parish Council website from menston.org to menston-pc.gov.uk
- Welcome to Menston signs Councillor White agreed to circulate a map showing the location of the proposed signs. Councillors Greer and White have agreed to arrange a meeting with Bradford Highways to discuss the proposals. It was agreed to add the invoice for artwork for £93.75 to the next agenda for payment.
- Parish Council notice board- the Parish Council agreed to accept the costs of £175 for remedial work and £75 to fit a new lock.
